4. Business Items and Call to Order

5. Presentation of the Special Resolutions and Motions to Approve – Maurine Karagianis, Board Chair

Roz Walls motioned that the CONSTITUTION of the Society be amended by Special Resolution by adding the following

(e) regarding the provision of rental supplements provided by BC Housing to Victoria Women's Transition House through the Canada-British Columbia Housing Benefit (CBCHB) program:

May Han motioned that the BYLAWS of the Society be amended by adding the following part 12.1:

"12.1 The Society will not alter or delete the shelter purpose set out in paragraph (a), the supportive housing purpose set out in paragraph (d), or the rent supplement purpose set out in paragraph (e) of its constitution and the Society will not alter or delete this bylaw without first obtaining the written consent of the British Columbia Housing Management Commission."

Roz Walls seconded the motion. All in Favour. Motion Approved.

Maurine Karagianis motioned to approve the extension of Board Member Liette Bates-Eamer's term on the board for one extra year, September 2024 – September 2025. Nikki Petersen seconded the motion. All in Favour. Motion Approved.
